Permission has been granted by the Barn Hunt Association, LLC for the holding of this Barn Hunt Fun Test under BHA Rules and Regulations.

This trial will be held indoors on rubber mats over concrete. Ample indoor crating is available. Vehicle crating is allowed. Blinds are 15x15 (#1) and 12x18 (#2) curtained areas indoors.
6 dogs per blind in Instinct, Novice and Open. 5 dogs per blind in Senior, Master and Crazy 8's.

One Trial - Classes Offered / Running Order: Instinct, Novice, Open, Crazy 8's, Senior, Master

Judge: Andrea Kulju BHAJ-279A Longville, MN - *judging all classes, consecutively*

RBJ: Donna Nisleit BHAJ-247A Juneau, WI

Judges are limited to 8 hours of judging and a maximum run value, which will require this Club to limit entries accordingly.

Entry Fees: \$5 per run for Instinct, \$10 per run for Novice, Open, Crazy 8's, Senior and Master

You may enter any class as many times as you would like.

This Fun Test is open to dogs of all breeds (and mixes) and sizes.

Dogs do NOT need a BHA number to participate in the Fun Test.

Entries open November 15, 2025 and close December 23, 2025

Day of Show entries will be accepted. Late and/or Day of Show entries are not a guaranteed entry and will be accepted only up to judging limits. Confirmations will not be sent for late entries.

Animal Safety: The safety of the dogs and the rats are our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and physically able to perform all course elements. Cancellation Policy: Every attempt will be made to hold this event as scheduled. In the event of an "Act of God" such as fire, flood, etc., an event may be canceled. We will make every attempt to contact entrants and inform them of the cancellation. We will return all or part of the entry fees at our discretion.

Refunds: Refunds offered only for injured or sick dogs with veterinary note. Requests for refunds must be made by the closing date. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by action of the Event Committee.

Returned Checks: A returned check does not constitute a valid entry, There will be a \$50.00 fee for all returned checks.

Awards: There are no awards for this Fun Test

Exhibitor Information: All dogs must be on a short leash and under control while on trial grounds except while showing. FLEXIBLE LEASHES ARE NOT PERMITTED. Refer to the Barn Hunt Rulebooks for additional collar restrictions. Pick up after your dog and dispose of waste in appropriate containers on the property. Any exhibitor failing to pick up after their dog may be fined and/or excused without benefit of a refund if the Event Committee determines the exhibitor to be in violation of this requirement.

Bitches in Season are eligible for entry but will be required to wear panties at all times, will crate and potty separate from all other dogs and will be run at the end of their class/trial. If you are bringing a bitch in season, please inform the trial secretary as soon as possible prior to the trial and inform all exhibitors at the general briefing.

Smoking and/or vaping are not allowed in the building or on trial grounds.
